

Figure 3.1: US and China - tariff increases to date



The Treasury portfolio is responsible for around a quarter of the total stock of Commonwealth legislation and around a quarter of the new legislation considered by the 45th Parliament.




Figure 5.1: Portfolio Bills in the 45th Parliament
