TIMING: Urgent

Recommendation

• That you note the advice received from the Commonwealth Chief Medical Officer (CMO) and ACT Chief Health Officer (CHO) confirming that the 2020-21 Budget lock-up events cannot go ahead in their usual format due to the health risks and restrictions caused by the COVID-19 pandemic.

• That you agree that, in line with this advice, alternative arrangements will be made for Press Gallery accredited media, to be given APS supervised access to embargoed Budget material in their usual place of business, namely the Press Gallery in Australia Parliament House (APH), with all COVID-19 mitigations and controls in place, for a four hour duration.

KEY POINTS

- To support the Federal Budget, Treasury usually organises a number of 4-6 hour events to provide embargoed access to Budget documents for journalists, stakeholders and parliamentarians ahead of the Treasurer's speech to the House of Representatives. In 2019, events included:
 - Media and parliamentarians lock-up at APH (829 people, including staff)
 - Stakeholder lock-up (including state and territory Treasuries) at Old Parliament House (279 people, including staff)
 - Supervised media sub lock-ups in media organisation offices in Sydney, Melbourne,
 Perth, Brisbane and Adelaide (11-53 people each).
- In light of the risks posed by the pandemic, these events cannot go ahead in their usual format. Most significant constraints include length of the event, number of attendees, location of attendees, and significant complexities arising from interstate travel restrictions.

• As the situation is rapidly evolving, it is difficult to predict whether the epidemiology and ACT restrictions will be more or less favourable in early October. There remains a significant risk that any arrangements in any capital city will need to be re-assessed closer to the time.

Risk assessment

- Treasury has sought advice on a number of alternative options for a physical gathering from the Commonwealth CMO and the ACT CHO (see Attachments A and B).
- Both CMO and CHO have strongly advised that giving embargoed digital access to the Budget documents would provide the lowest risk.
- On advice from the Office of Health Protection, the CMO has further advised that should a physical lock-up go ahead, that Treasury ensure more than the currently advised physical distancing space for attendees (i.e. more than 4m² per person) is provided.
- Treasury has confirmed with both offices of the CMO and CHO that should embargoed access to Budget material be provided to individuals in their usual place of business (rather than an organised gathering) this would be a significantly lower the risk and remove the need to impose a time limit. It will be essential that proper COVIDSafe practices are still followed by these workplaces.
- Treasury will need to source staff from across the APS to manage these events and ensure that we meet our obligations under the *Work Health and Safety Act 2011* (WHS Act). Under the WHS Act, the Secretary of the Treasury and key Senior Executive Service officers have a responsibility to ensure the health and safety of staff while they are at work in the business or undertaking.

Proposed approach

• To effectively manage the risk and provide sufficient time for individuals to access the embargoed Budget material, Treasury has put together the following proposed approaches. Further details of how these activities will be conducted is at Attachment C.

<u>Media</u>

- alternative arrangements be made for Press Gallery accredited media to access embargoed Budget material in their usual place of business, namely the Press Gallery in APH for a four hour duration;
 - : this activity would need to be supervised by APS officials
 - : all COVID-19 mitigations and controls for the workplace would need to be maintained
 - for both COVID-19 controls and security controls, all non-essential staff will need to vacate the Press Gallery by 3pm. Where that is not possible for operational reasons, media with access to Budget material must work in a designated space and not communicate with their colleagues who do not have access to the Budget material.

OFFICIAL SENSITIVE

- the question and answer process with departmental officials will be conducted virtually or via phone.
- as in previous years, three major media organisations in Sydney, Melbourne, Brisbane, Adelaide and Perth will remain in their usual place of business and be permitted to connect virtually to their Press Gallery staff, to access embargoed Budget material for a four hour duration:
 - : this activity would need to be supervised by APS officials
 - : all COVID-19 mitigations and controls for the workplace would need to be maintained
 - : for Melbourne-based workplaces, advice will be sought from the Victorian Chief Health Officer on what arrangements are possible under current restrictions with relevant COVIDSafe plans being in place for these workplaces.
 - : these activities have previously been permitted for:
 - (i) News Corp Australia in Sydney, Melbourne, Adelaide and Brisbane
 - (ii) Nine Network (publications) in Sydney and Melbourne
 - (iii) Seven West Media in Perth
 - : in addition this year it will be permitted for:
 - (i) the ABC in Sydney
 - (ii) Sky News Australia in a location to be confirmed.
- the Treasurer's press conference be held in the Main Committee Room at APH, complying with the COVIDSafe restrictions that set room capacity of 70 people, with the Press Gallery to nominate up to 50 attendees (inclusive of journalists and camera/sound operators).
- Treasury will work with the Department of Parliamentary Services (DPS) and the Presiding Officers to confirm all APH activities are approved and comply with the building's COVIDSafe work plans.

Non-Government MPs and Senators

- alternative arrangements be made for non-Government MPs and Senators to access embargoed Budget material, in their usual place of business in Canberra, namely their APH offices for a four hour duration:
 - : this activity would need to be supervised by APS officials
 - : all COVID-19 mitigations and controls for the workplace would need to be maintained.
 - : Treasury will work with DPS to determine the COVIDSafe capacity of each meeting room in all suites and provide clear advice on the staff numbers able to attend in each instance, noting the need for an APS supervisor to be present.

- alternative arrangements be made for non-Government MPs and Senators who will not be in Canberra on Budget day to access the embargoed Budget material in the Commonwealth Parliamentary Offices in their local capital cities for a four hour duration;
 - : this activity would need to be supervised by APS officials
 - : all COVID-19 mitigations and controls for the workplace would need to be maintained.

Stakeholders

- That you agree to two in-person stakeholder lock-up events be held, in Sydney and Canberra, to provide embargoed access to Budget material for a maximum two hours duration;
 - : this activity would need to be supervised by APS officials
 - : all COVID-19 mitigations and controls for events and gatherings in these jurisdictions will need to followed.

Staffing

- While travel restrictions prevent Treasury staff from travelling interstate to supervise these events, Treasury will identify local APS officials to provide oversight and supervision. Treasury has drawn on support from local Australian Taxation Office (ATO) staff in previous years and will work with the Australian Public Service Commission to identify a wider pool of staff that can also be called upon to assist. This may include drawing on other APS agencies with geographically disperse staff such as the Australian Border Force.
- We will need to ensure that staff involved in these events are provided a COVIDSafe environment to meet our obligations.

Physical and digital security

- This year's Budget events will follow the strictest physical and digital security protocols to date, to ensure the health and safety of staff and attendees and the security of the information being provided under embargo to members of the media, Parliament and stakeholders.
- APS officials will physically supervise all venues where Budget material will be accessed in hard copy or digitally.
- Treasury will work with the appropriate agencies to develop a detailed cyber security plan which will be provided to the Office in the coming week. This will outline the arrangements being put in place to provide the utmost digital security to the embargoed Budget material prior to its official release.
- For a number of years, Treasury has used SigBox to securely transmit Budget material to media sub lock-ups. This is secure file-sharing platform accredited to store Protected-level government data. This system will be employed again this year to provide secure transmission of Budget material to all locations outside Canberra. Further document controls will also be

employed to deter unauthorised transmission of Budget material. Full details to be provided as part of the cyber security plan.

- Embargo conditions will be enforced in every location and all attendees will be required to execute a Deed of Confidentiality as a condition of their accessing embargoed material. Breach of the deed will be treated very seriously by the Treasury and legal action will be taken to enforce the Commonwealth's rights.
- As in previous years, Treasury will require all mobile phones or devices capable of transmitting to be surrendered. Any laptops or other equipment needed for work will need to be kept in 'flight-mode' unless being used for pre-approved communication channels within their own offices. Platforms such as WhatsApp, Messenger, other internet-based message systems and web-based email cannot be secured and must not be used.

Next steps

- Subject to your agreement to these proposed activities, the Secretary to the Treasury will write to the Press Gallery Committee and selected stakeholders to advise them of the conditions for embargoed access to this year's Budget material.
- This communication will detail the strict controls being put in place for embargoed access to this year's Budget material, the expectations of them as participants in these activities and the legal consequences should they breach any of the terms and conditions. This will also extend to their own obligations to maintain COVIDSafe workplace environments and ensure appropriate controls are followed.
- As is standard practice, a letter will be prepared for you to send to non-Government MPs and Senators to advise them of the embargoed access arrangements to this year's Budget.

Dear Roxanne,

Thank you for your correspondence on the 28 August 2020 requesting written advice on your COVID-19 risk mitigation proposals for the 2020 Budget Lock-up.

During the period of our discussions on this issue, the epidemiological environment with regard COVID-19, has deteriorated. There is community transmission in Victoria and there is considerable concern that there is community transmission in New South Wales and also in Queensland. There is currently an intense public health focus on preventing further spread.

An event that brings together attendees from different areas of Australia who do not normally interact increases the risk of a transmission event. This may seed an outbreak in areas in Australia currently unaffected by COVID-19 and, in addition to workplace consequences, this could also adversely affect the broader Australian community and incur considerable health expense, increases in morbidity and mortality, and economic cost related to associated business shut downs.

With regard the scenarios you outlined in your letter, all those that require extended confinement and interstate attendees carry increased risk. For Option B, I agree with your rating of 'low-medium' and note that that Option B is the lowest risk scenario presented. I would comment that a virtual lock-up would eliminate the COVID-19 risk completely and perhaps this should be considered.

I agree with your assessment of Option D as higher risk at 'medium to high' because of the protracted confinement. Increased time in a closed environment increases risk of transmission.¹

With regard Options A and C, noting that these involve interstate participants, unless attendees from hotspots were required to undertake a strict two week quarantine, I would consider both of these options to be 'very high risk'.

I hope this is helpful. I am happy to provide additional input as required when you determine your course of action on this issue.

2020 Budget Lock up Proposals

Thank you for your letter dated 28 August 2020 in which you seek my feedback on four proposed events to deliver the traditional budget lock up scheduled for 6 October 2020.

I have reviewed all four proposals and have attached my comments against each of those for your consideration.

The points below summarise the feedback:

- The duration of any event should be minimised and would preferably be restricted to less than 2 hours.
- Gatherings should ensure that there is four square metres available for each person, up to a maximum of 100 people per indoor space. Individuals who do not normally work together should also maintain physical distance of 1.5 metres.
- Full cohorting and no movement between the different gatherings is essential to reduce risk of wider spread if a case is introduced.
- Any travel into the ACT from other jurisdictions must follow the travel advice available
 on the ACT Government website. I would caution any travel from Victoria, noting that
 border restrictions are in place, as well as COVID affected areas of Queensland and NSW.
- Quarantine requirements will apply for entry into the ACT from Victoria. In addition, any travel from the ACT to home jurisdictions may also result in quarantine requirements being imposed by the relevant jurisdictions.

I understand the importance of hosting a budget lock up event. While the decision on the format of the event is a matter for the Treasury, I would strongly suggest that consideration is given to hosting a virtual/digital lock up event as this would provide the lowest risk.

Alternatively a series of smaller events, limited to less than two hours, could be held across Canberra and in other states and territories, with attendance limited to individuals who reside in those jurisdictions. This would avoid any interstate travel. I trust that this advice assists you in your considerations.

Feedback from the Office of Chief Medical Officer (Federal)	The event as described requires interstate travel, brings together people who may not regularly interact, in an indoor environment for a prolonged period in an unfavourable epidemiological environment. Whilst it is noted that the decision to run the event lies with Treasury, it is considered unlikely that controls will adequately mitigate risk in its current format. The event is still considered to be very high risk and alternate options should be considered.
ACT CHO Risk Rating	Very High Risk – Not recommended
ACT CHO advice on Travel/ Quarantine Exemptions	Interstate travellers would need to follow travel advice on the ACT Government Website. At present travel to the ACT from Greater Sydney is discouraged.
	Entry to the ACT from Victoria can only be by exemption for non ACT residents. Exemptions could only be granted if individuals were prepared to quarantine in the ACT for 14 days prior to attending the lock up event.
	Quarantine requirements may also apply on return to home jurisdictions.
Other comments from ACT CHO	The gathering of individuals from different workplaces and from several jurisdictions, together with the length of the event, presents significant risks.

Access to Budget material

The below outlines how the Treasury will provide supervised access to embargoed Budget material for media, non-government stakeholders and non-government MPs and Senators.

All relevant all COVID-19 mitigations and controls will be in place for each group.

INFORMATION SECURITY

This year, access to Budget material will follow the strictest security protocols ever applied to ensure the health and safety of staff and attendees, and the security of the information being provided under embargo to members of the media.

The Treasury will require all people accessing Budget material prior to 7.30 pm, Tuesday 6 October, to execute a deed of confidentiality. This is a significant legal document. Breach of the deed will be treated very seriously by the Treasury and legal action will be taken to enforce the Commonwealth's rights.

All people with access to Budget documents will be supervised by APS officials.

All equipment that is capable of transmitting information (eg laptops and tablets) must be in in flight mode until the embargo is lifted.

Mobile phones or smart watches must turned off and will be kept by APS officials until the embargo is lifted.

Media

ACCESS TO DOCUMENTS

Budget material will be available to accredited Members of the Press Gallery from 3 pm-7.30 pm on Tuesday 6 October.

Budget information is not to be broadcast, published or made publicly available in any way until its official release when the Treasurer begins his Budget speech (usually 7.30 pm) on Tuesday 6 October.

As agreed with the Press Gallery Committee, the Treasury and other Australian Public Service (APS) officials will be present to supervise access to Budget material.

Access to the material will be in Press Gallery office/s. Documents will be available in hard copy and on USB.

To ensure sufficient hard copies are available, media organisations must provide the name/s of staff who require access to Budget documents to the Treasury by 11 September

COVID-19

Media organisations must have an appropriate COVIDSafe risk mitigation plan in place, and ensure their staff are following COVIDSafe work practices. This includes appropriate physical distancing and hygiene controls, excluding staff that are unwell, and adhering to current ACT Government advice for people traveling to the ACT.

APS officials will follow COVIDSafe work practices.

PERMITTED STAFF

Access to Budget material will only be available to accredited Members of the Press Gallery with permanent desks/offices in the Australian Parliament House Press Gallery who:

- 'normally' work at the Press Gallery office/s at APH
- are employed by their organisation
- are ACT residents.

Media who are not working on Budget material should not be present in the Press Gallery office/s.
