Schedule 1 Amendments

Schedule 1—Amendments

Specialized Agencies (Privileges and Immunities) Regulations 1986

1 At the end of regulation 9

Add:

- (9) A person who is performing, whether alone or jointly with other persons, a temporary mission on behalf of a Specialized Agency to which this subregulation applies, has the privilege specified in paragraph 2A of Part I of the Fifth Schedule to the Act.
- (10) Subregulation (9) applies to each of the following:
 - (a) the International Monetary Fund;
 - (b) the International Bank for Reconstruction and Development;
 - (c) the International Finance Corporation;
 - (d) the International Development Association.

12 Application and transitional provisions

The amendment made by Schedule 1 of the *Specialized Agencies (Privileges and Immunities) Amendment Regulations 2021* applies in relation to salaries and emoluments received on or after 1 July 2017.
