The government remains committed to improving corporate tax transparency but has deferred the application date of the country-by-country reporting by 12 months (1 July 2024). The public country by country reform attracted broad stakeholder interest and the government is taking some additional time to reflect on this feedback, to progress meaningful improvements in transparency to enhance public scrutiny on corporates' tax arrangements, balancing this with appropriate compliance burdens on industry. The government will progress this work over the coming months and welcomes engagement from all stakeholders.
