Just stepping in for Deb here.

There is about 30 minutes set aside for questions between just Patricia and the Minister, and then there will another 25 minutes or so devoted to questions coming from the audience – which could include journalists.

Patricia will open up with a very broad question about Labor’s vision for super – which will give the Minister a chance to give a longer answer 5 minutes or so – depending on the answer Patricia may have follow ups.

The other areas likely to be covered are:

- Unpaid super – including our main policy as which is payday super
- Equity in super – including paying super on Commonwealth parental leave pay
- The \$3 million tax
- The Objective of Super and potential political fight on preservation
- The government’s response to the Your Future, Your Super review (I’d also expect a technical question or two from the audience on this topic)
- Super being used for nation building
- And the quality of financial advice review

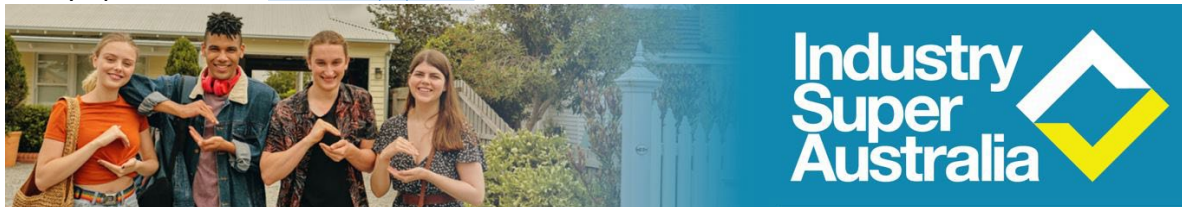
